DEFINITIONS

End Order Date The date when the game is automatically removed from the Telemarketing application prohibiting additional ticket orders from the retailers and further distribution in the field.

End Activation Date The date when the retailer may no longer activate any new packs of the game.

Official End of Game Date The date when retailers are instructed to stop selling, and players are notified to stop buying, the game. This date shall be the same as the "End Activation Date" and shall trigger the "End Validation Date."

Settle Date The date when all activated packs are automatically settled on the gaming system.

End Validation Date The date after which players may no longer claim their winning tickets.

End Return Date The date used to determine if the pack is okay to return tickets on the terminal. Setting this date will prevent old games from being returned on the system.
